1. Implementation steps

- 1st step:** **Prototype for Russian to German**
 Conception, development, programming, testing and completion
 >>> **from here on (approx. 6 months from START) money is earned**
 (approx. 210 million Russian-speaking people worldwide)
- 2nd step:** Extension by additional languages
- 3rd step:** Extension modules for technical-languages, specified modules, simultaneous translation modules, exam modules etc.

Currently recorded languages:

German, English, French, Spanish, Portuguese, Italian, Croatian, Turkish, Polish, Russian, Bulgarian, Chinese, Japanese, Arabic, Indonesian, Hungarian. The system is suitable **for all languages**.

The AVATAR-Project is **an essential part of the existing platform for Carehomes, Doctors & Patients** of the **International HUMANITY Organisation AG, IHO**.

2. Breakdown of tasks

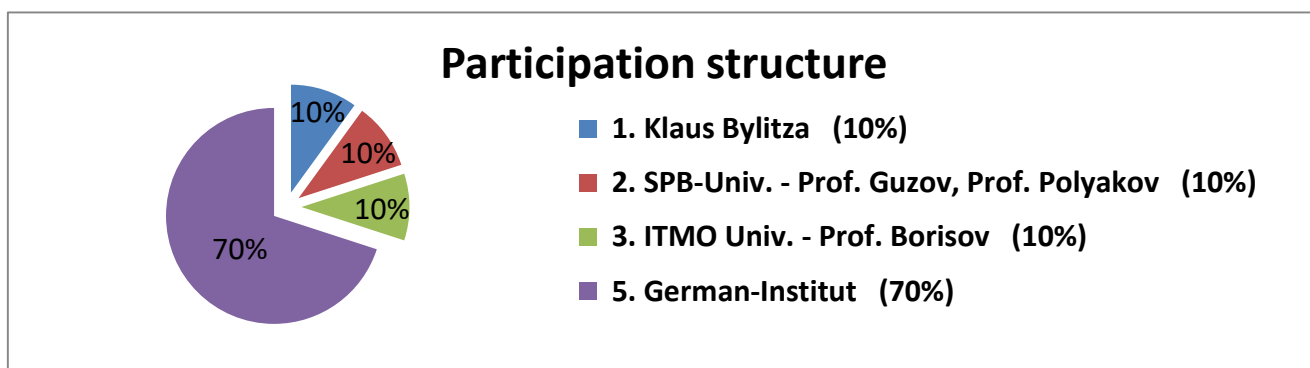
- 1. Klaus Bylitza**
 - Delivers the Bylitza-System and its know-how to the individual languages.
- 2. University St. Petersburg**
 - Project coordination and management in Russia, scientific supervision and support (**Prof. Guzov, Prof. Polyakov** and scientific staff)
- 3. ITMO University St. Petersburg**
 - Concept development, programming, creation of the prototype, testing, technical implementation, further development, technical support, updates (**Prof. Borisov** and scientific staff)
- 4. Investor**
 - **Financial support, EUR 2.5 million**
- 5. German-Institut**
 - Management and overall coordination, project responsibility and management, company foundation (1 million shares, in the second step splitting the stock x100)

3. Process flow (AVATAR)

- Registration, log in, holo glasses / VR glasses
- Selection of the source and target languages
- Welcome by the avatar and explanation of the system
- Decision for a specific language / module and selection
- Booking / payment of the selected module (exact money generation must be calculated in the trial phase)
- Interactive language training with final exam.

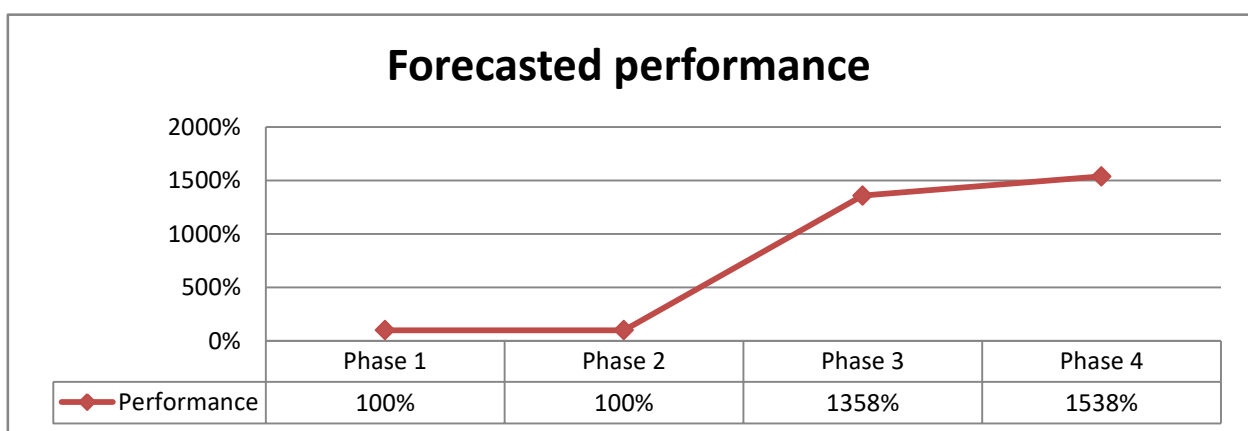

The Bylitza-System makes it possible to learn a foreign language in three days and speak it.

1st Prof. Dr. Iurii Guzov, Vice-Dean of the Faculty of Economics of the University of St. Petersburg and

2nd. Prof. Dr. Nikolay Borisov, Director of the Center for Multimedia and Design of ITMO University Saint Petersburg.

ITMO University is the best IT university in Russia. (Kasperski studied there, the developer of Kasperski Virus Protection).

Prof. Borisov has a very good and professional team of programmers with the very best programmers.

6. LOI

We already signed an LOI on August 7th and decided to jointly implement the AVATAR project.
